

Submission Preparation Checklist

As part of the submission process, authors are required to check off their submission's compliance with all the following items, and submissions may be returned to authors that do not adhere to these guidelines.

1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
2. **Permitted Uses of Artificial Intelligence (AI) by Authors and Reviewers:** AI tools can be used for editing, improving readability, and structuring, provided there is human oversight and explicit disclosure (e.g., Final version was edited to improve readability and fluency with assistance from ChatGPT-4. The author(s)/reviewer(s) reviewed all generated suggestions and take(s) full responsibility for the content of the publication.
3. **Prohibited Uses of AI by Authors:** The use of generative AI in data analysis, identification of results, or preparation of any part of the manuscript is strictly prohibited. The author(s) must declare that they have not used any type of generative AI for the writing of the manuscript other than those items specifically listed as permitted by JIPE (see above). Authorship implies responsibilities and tasks that can only be attributed to and performed by humans.
4. The submission file is in Microsoft Office doc or docx format.
5. The submission includes a financial disclosure statement at the end of the manuscript
6. The text is double spaced, uses a 12-point font, 1-inch margins and is no more than 30 pages in length.
7. The text adheres to the stylistic and bibliographic requirements outlined in the Publication Manual of the American Psychological Association, sixth edition.
8. The manuscript has been divided into separate files as directed in the author guidelines above.
9. Any potentially identifying information, including but not limited to name, affiliation, or contact information, has been removed.

Manuscripts must be double spaced, use a 12-point font, 1-inch margins and be no more than 30 pages in length, including abstract, references and tables.

The manuscript should be submitted in separate files:

1. Authors Details page
2. Main Article file

The authors details file should contain:

1. Full title, short title and the names and affiliations of all authors

2. Full address information, including e-mail, telephone and fax, of the corresponding author(s)
3. Name(s) of any sponsor(s) of the research contained in the article, along with grant number(s)

Main Text File

As papers are double-blind peer reviewed the main text file should not include any information that might identify the authors. The main text file should be presented in the following order:

- I. Title, abstract and keywords, Plain Language Summary, Main text, Financial Disclosure Statement
- II. References
- III. Tables (each table complete with title and footnotes)
- IV. Figures
- V. Appendices (if relevant).

Figures and supporting information should be supplied as separate files. The main manuscript file should include an abstract of up to 100 words.

Please provide 3 to 5 keywords, separated by semicolons (;).
